Sub: CMDA – Administration Bills (Main) Division – Pension – Production of Life Certificate, Non-Employment Certificate, Non-Marriage/Non-remarriage Certificate by the all Pensioners / Family Pensioners for the year 2018-2019 – Requested – Regarding.

In the G.O. 1<sup>st</sup> read above, the Government has ordered that the Pensioners / Family Pensioners shall produce Life Certificate / Non-employment Certificate and Non-Remarriage/Non-Marriage Certificate as the case may be to the concerned Pension Disbursing Officer every year before 31<sup>st</sup> July of every year.

2. In the G.O. 4<sup>th</sup> read above, Government has instructed that attested Life Certificate shall be submitted by the Pensioners and Family Pensioners – but for Non-employment / Re-employment Certificate and Non-remarriage / Non-marriage Certificate self attestation is sufficient.

3. Therefore, I am to request you to produce the above certificate on or before 31.07.2018. If the same is not received on or before 31.07.2018, you have to appear for mustering before the concerned Pension Disbursing Officer during the month of August 2018. If the same is not produced before 31.07.2018 and if the pensioner has also not appeared for mustering on or before 31.08.2018 payment of Pension/Family Pension will be stopped from the month of September 2018.
