**Appointment**

Appointment to the post will be on contract basis. The duration of the assignment is initially for a period of 3 years from the date of award of contract and likely to be extended based on the performance and project period.

The consultant will be paid with a maximum remuneration of approximately **Rs.39,00,000/- per annum.**
