ORDER:-

During the review of Housing and Urban Development Department by Hon'ble Chief Minister on 13.07.2011 and during the follow up meeting held on 22.07.2011, the issue of decongestion of the Chennai Mofussil Bus Terminal was discussed.

2. The Member-Secretary, Chennai Metropolitan Development Authority in his letter read above has requested the Government to accord administrative sanction for the following:

- i. Developing a satellite inter-city bus terminal at an approximate cost of Rs.32,00,00,000/- in the vacant site measuring about 8 acres within the Madhavaram Bus and Truck Terminal by shifting some of the bus services operated through the GNT road and developing another satellite inter-city bus terminal at an approximate cost of Rs.48,00,00,000/- in vacant site measuring about 12 acres within the 15 acres site located near the Velachery Rapid Transit System Station (as part of the bus inter-change to the Mass Rapid Transit System) by shifting some of the bus services operated through the East Coast Road and Old Mahabalipuram Road.
- ii. As in the case of the Chennai Mofussil Bus Terminal, the Chennai Metropolitan Development Authority would plan and develop these 2 satellite inter-city bus terminals by accessing the funds under the Infrastructure and Amenities Charges; and
- iii. The Chennai Metropolitan Development Authority would prepare necessary feasibility reports on these two satellite bus terminals by

itself through consultants or getting these reports prepared by M/s.Tamil Nadu Urban Infrastructure Financial Services Limited through consultants.

3. The Government after careful examination have decided to accept the proposal of Member-Secretary, Chennai Metropolitan Development Authority. Accordingly, the Government accord administrative sanction for the following:

- i. Developing a satellite inter-city bus terminal at an approximate cost of Rs.32,00,00,000/- (Rupees Thirty Two Crores only) in the vacant site measuring about 8 acres within the Madhavaram Bus and Truck Terminal by shifting some of the bus services operated through the GNT road and developing another satellite inter-city bus terminal at an approximate cost of Rs.48,00,00,000/- (Rupees Forty Eight Crores only) in vacant site measuring about 12 acres within the 15 acres site located near the Velachery Rapid Transit System Station (as part of the bus inter-change to the Mass Rapid Transit System) by shifting some of the bus services operated through the East Coast Road and Old Mahabalipuram Road.
- ii. As in the case of the Chennai Mofussil Bus Terminal, the Chennai Metropolitan Development Authority would plan and develop these 2 satellite inter-city bus terminals by accessing the funds under the Infrastructure and Amenities Charges; and
- iii. The Chennai Metropolitan Development Authority would prepare necessary feasibility reports on these two satellite bus terminals by itself through consultants or getting these reports prepared by M/s.Tamil Nadu Urban Infrastructure Financial Services Limited through consultants.


