It was informed to the Committee that the St.Isabel’s hospital is similar to the CSI Kalyani Hospital in the same locality namely Mylapore. On an earlier occasion Kalyani Hospital was dealt with by the Government on appeal, as an institutional development and orders were issued relaxing the violated rules. Currently, an application from Kalyani Hospital for additional construction is also dealt with as for institutional development. In respect of St. Isabel’s Hospital, a Planning Permission Application submitted earlier in 1998 was processed in the institutional channel applying institutional parameters.

Considering the definition of commerce and commercial use in the T&CP Act 1971 and also that the applicant is a charitable trust, the Committee resolved to accept the request of the applicant to consider and examine the development under the institutional use category and levy the regularisation fee accordingly.

Hospital) on the adjacent site ; further, the adjacent site also, as on ground gains access through the passage of Diabetic Research Centre site. Hence, it is not regularisable.**

**Minutes** **The Monitoring Committee on going through the file resolved to accept the industrial buildings in Royal Enfield Motors in S.No.6/1B1A,10/1,2pt, 11/1,2,3 and S.No.9,T.S.No.32,33/2 & 34 of Tiruvotriyur Village had been completed prior to 28.02.1999.** The property tax assessment No.10541/1998-99-II of Tiruvotriyur Municipality, Certificate of Stability as per Indian Factories Act, dt. 28.01.1999, the approved plan for the extension of Heat Treatment Plant, Research & Development Wing building issued by Tiruvotriyur Municipality,dt.07.03.1981 and TNPCB consent order No.3223,dt.11.02.1991, Letter from the Deputy Inspector of Factories, Madras-35 No.CG/526/Regular/87, dt.02.03.1987 were accepted as credible evidence. The TNEB letter No.DN.825/AE1/C12/HT/1049/D/66-2, dt.08.07.1982, Electricity Consumption payment advice, dt.29.05.1998 and 30.08.'99 for the months of 5/98 and 8/99 were considered as supportive evidence and the Monitoring Committee

  - 1) 3<sup>rd</sup> floor pt. AC sheet roof in Administration building;
  - 2) 3<sup>rd</sup> Floor AC sheet roof in Esprit building;
  - 3) AC Sheet lean to roof at Vehicle Assembly Shed on southern side; and
  - 4) AC sheet shed at Product Test Lab on western side.

The application of CRZ.II guidelines to this case has to be examined separately.

**Minutes** On examining the report, the Monitoring Committee expressed its concern on the poor performance by the Local Bodies in taking effective enforcement action against unauthorised / deviated constructions. The Monitoring Committee decided that (1) an updated status report on action taken against the buildings for which demolition notices and Locking and Sealing Notices were issued and (2) the plan of action against unauthorised / deviated constructions be obtained from all the local bodies including Chennai Corporation and may be placed before the next Monitoring Committee meeting.

## **GENERAL**

With regard to individual flats scrutiny, the details of Undivided Share of land and built-up area as applied as per CMDA Inspection Report / as per Property Tax assessment details may be furnished in the Data Sheet along with approved floor area details. Locus-standi of the applicant to apply for regularisation of the individual flat in a building may be examined and brought out.

In the 38<sup>th</sup> Monitoring Committee meeting and as well as in the present meeting, T.Nagar Redevelopment Plan issue proposed by Corporation of Chennai was discussed. The Corporation of Chennai is requested to furnish a report to the Monitoring Committee on the proposed T.Nagar Redevelopment Plan.

Non-official Members expressed their concern and requested apart from individual Regularisation application cases, to place all other important issues before the Monitoring Committee.

CMDA reported that in about 1057 cases the High Court has issued orders for providing service connections without insisting on Completion Certificate. As per the Monitoring Committee's decision, so far 15 Writ Appeals have been filed in the High Court. Monitoring Committee decided to file Writ Appeals against such High Court orders and take follow up action on the Writ Appeals already filed.
