In the reference 1st read above, the Government have directed that only statutorily required No Objection Certificates can be insisted upon for processing of Planning Permission Applications (copy enclosed). In continuation of this, Additional Chief Secretary to Government and Vice-Chairperson, CMDA had a meeting on 07.05.2009 and directed to adhere to the Government directions(copy enclosed). In the reference 3rd read above the Government in Home Department have stated that in respect of religious buildings, the procedures to process applications for approval now in vogue may be continued till a decision is arrived at by the Government.

Accordingly, it is hereby ordered that the statutorily required NOCs as per Development Regulations alone need to be insisted upon for processing the applications. It is also ordered that hereinafter MSB and Special Building applications should be admitted only if they are accompanied by all the statutorily required NOCs.
