ELIGIBILITY CRITERIA

1. The bidder shall be a registered / reputed firm in India having experience in collection of parking fee in any State / Central Government Department / Government Undertakings using boom barrier system with computerized billing and should have been in similar business during the past five years in India (from April 2012 to March 2017).
2. The bidder should have experience in similar work of collection of parking fee for a minimum period of 5 years with an Annual Turn Over of **Rs.4.80 crores in any one of the preceding five years (from April 2012 to March 2017)** and should have completed at least one single work of total Collection to a value of **Rs.1.60 crores / Annum** (under single agreement) in any one of the preceding five years (**i.e. From April 2012 to March 2017**) for consideration and furnish the completion certificate issued by the employer and proof of Annual Turn Over for consideration.
3. The tenderer should furnish the performance / Experience certificate, Firm Registration and Annual Turn Over, in order to be eligible to participate in this tender (Duly attested by the Notary (or) Gazetted officer).
4. The tenderer must not have been debarred or black listed or terminated by any of the Central/State Govt. Departments /Govt. Undertakings / Govt. Entities. The bidder should not be a defaulter in making payment to any Govt. Organization / Undertakings / Government Entities. Self declaration should be furnished in non-judicial stamp paper for the value of Rs.100/-.
5. The tenderer should furnish latest Income Tax Return/Saral and GST Registration certificates, etc. duly attested by the Notary Public at the time of tender for consideration.

PARTICULARS ABOUT TENDER

1. The tenderers are required to simultaneously submit two separate sealed covers i.e., one cover containing the required Earnest money deposit and details of their capability and Pre-Qualification document (cover I) to undertake the work which will be opened first. The second cover containing the price bid document will be opened only if the tenderer is found qualified, for which the opening date will be informed later to the qualified bidder.

The tender document and other particulars can be had from the O/o Executive Engineer, Construction Wing, Division-I, CMDA., Tower-II, 9th floor, No.1A, Gandhi Irwin Road, Egmore, Chennai 600 008 on requisition in writing with necessary attested copies of certificates in support of their registration as Contractor, experience certificate, latest Income tax, GST Registration certificates etc, and on payment of the cost in cash / Demand Draft as indicated in Column No.4 above (non-refundable) on all working days from **17.11.2017 to 14.12.2017** during Office hours between **10.00 a.m. and 4.00 p.m.** The Demand Draft / Banker's Cheque should be in favour of the Executive Engineer, Division-I, CMDA and payable at Chennai.
