The Monitoring Committee on going through the file observed that in the evidence given by the applicant by way of Corporation of Chennai Working Sheets there is a variation in extent between the Regularisation application submitted by the applicant during 2000, CMDA working sheet calculation and property tax assessment by Corporation of Chennai. The Monitoring Committee also noticed that the Working Sheet for the year 2/1998-99 has been furnished during the year 2010. Hence, it was decided to call for the Corporation working sheet duly attested by responsible officer in Corporation of Chennai to check the genuineness and then again place it before the Monitoring Committee for suitable decision.

The Monitoring Committee requested Chennai Corporation to examine if there is a revenue loss as the variations in the figures of built up space suggest.

It was also decided that in future the Reg. division may produce the corporation file for verification by the Monitoring Committee.

The applicant has not furnished Corporation property tax working sheet for the period II/98-99 or prior, details on number of floors and total building area for having completed the building on or before 28.2.1999.

The Monitoring Committee has also suggested Corporation of Chennai to take necessary action for the removal of the road encroachment.

Also the applicant has put up additional construction of 6th floor (part) and 7th floor (part) after filing the Regularisation application under Reg. Scheme 1999.

The Monitoring Committee has also suggested the Corporation of Chennai for taking necessary action on the 0.76 m wide aerial encroachment on the road portion.

The Monitoring Committee on going through the file resolved to recommend rejection of the appeal to the Government for the Regularisation of an unauthorized deviated Residential building (now converted as commercial) of GF + 4 Floors at Plot No.E-30, 2nd Avenue, Besant Nagar in S.No.153 of Thiruvanmiyur Village for the following reasons:

The applicant has furnished Corporation tax receipt, working sheet dt.1.3.1999, which shows that the extent of 4th floor is only 2000 sq.ft., whereas during inspection on 13.5.2011, it was noticed that the entire 4th floor is constructed to the extent of 2600 sq.ft. Also the entire building is converted from residential use to commercial use after 28.2.1999.

Minutes

The Monitoring Committee on going through the file resolved to recommend rejection of the appeal to the Government for the Regularisation of GF+2 floors residential building with 9 dwelling units at Door No.2/5, Vijaya Street, Vadapalani, Chennai-26, T.S.No.1/16 and 1/17, Block No.1 of Kodambakkam Village:

The Monitoring Committee has also noted that GPA has been given by Tmt.V.R.Leela and Thiru.V.G. Thangamani only for an eaxtent of 2616 sq.ft. to Thiru Vetriselvan, GPA, whereas the site extent is 3262 sq.ft., which is excess by 640 sq.ft. for which Thiru Vetriselvan, GPA has no right for applying Reg. planning permission. In this regard, the Senior Law Officer of CMDA has given his opinion for processing the regularisation application based on the patta furnished by the applicant for the entire extent. Based on the SLO's opinion, the Reg. Application was processed.

The Monitoring Committee decided to re-examine the opinion given by the Senior Law Officer, CMDA as the GPA Thiru Vetriselvan has no right for the excess land of 640 sq.ft.

CMDA – Reg.III Dn. – Regularisation of Ground floor + 2 floors residential building at D.No.5 and Plot No.39, Seethammal Colony 2nd Main Road, S.No.3766/3 part of Mylapore village, Chennai – Rejected – Appeal to Government against rejection under section 113-A (6) – Placed before M.C. for decision.

The Monitoring Committee on going through the file resolved to recommend rejection of the appeal to the Government for the Regularisation of Ground floor + 2 floors residential building at D.No.5 and Plot No.39, Seethammal Colony 2nd Main Road, S.No.3766/3 part of Mylapore village, Chennai for the following reasons:

- i) The applicant has not furnished evidence to prove that the building was completed before 28.2.1999.
- ii) On re-inspection dated 26.12.2011 it was noticed that the applicant has put up additional construction and converted part of the 2nd floor from residential use to office use. Also, the terrace floor a room of size 15'x9' with fibre sheet roof has been constructed.

The Monitoring Committee on going through the report submitted by the DF&RS in respect of 21 Multi Storeyed Buildings in Kodambakkam area expressed grave concern at the widespread deficiencies in fire safety provisions in these buildings and decided as follows:

 Within the frame work of act provisions Corporation of Chennai and CMDA shall take action on the violated buildings in terms of fire safety aspects.

- ii) Corporation of Chennai can also examine whether they can delegate powers to DF&RS for taking necessary action against the buildings for which no fire safety methods has been adopted. DF&RS also can issue notices to these buildings for not taking necessary fire safety measures.
- iii) DF&RS may submit a copy of the proposal sent to Government for the perusal of the Monitoring Committee.
- iv) The above is applicable even for the T. Nagar buildings.

CMDA – EC(North) – Monitoring Committee suggested to carry out survey of Special and Multistoreyed commercial buildings abutting 2nd Avenue and 4th Avenue (Shanthi Colony) by Corporation of Chennai – Survey report – Placed before 45th Monitoring Committee – Cross check and to give independent report on correctness suggested to CMDA – Report placed before the Monitoring Committee – Reg

Minutes

The Monitoring Committee on going through the survey report submitted by CMDA on the Multi-Storeyed Commercial buildings abutting 2nd Avenue and 4th Avenue (Shanthi Colony) observed that the independent survey report given by CMDA reveals higher order deviations in many of the buildings surveyed by the Corporation of Chennai. Hence, the Monitoring Committee suggested Corporation of Chennai to cross check with the report furnished by the CMDA and take necessary action.

- (i) Regarding digitisation of records it was discussed that the main purpose of documentation is to monitor the movement of regularisation applications. The information to be retrieved like details of disposal of reg. Application, area, category, street, rejection, approval, appeal etc.,
- (ii) As exclusive teams have been constituted for enforcement action in CMDA and Corporation of Chennai delegation of powers shall be given to the concerned in CMDA and Corporation of Chennai for taking necessary action.
- (iii) The telephone numbers and email addresses of these officers to be publicized.

- (iv) Diagnostic study of a few EC files be taken up to identify delays, bottlenecks, etc and presented before the ensuing Monitoring Committee meeting.
- (v) Progress of Enforcement action taken against Reg. rejected cases, cases generated by area study reports commissioned by the monitoring committee etc., may be submitted as a regular agenda item in the monitoring committee meeting.
- (vi) A list of cases, wherein the Hon'ble Court has ordered for giving power supply, water supply and sewerage connections to be placed before the ensuing Monitoring Committee meeting with details of the deviations.
- (vii) In respect of the above cases enforcement action should be initiated including forfeiture of security deposit.
